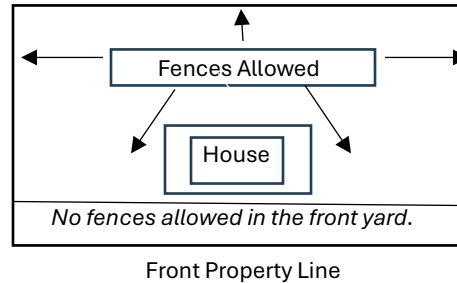

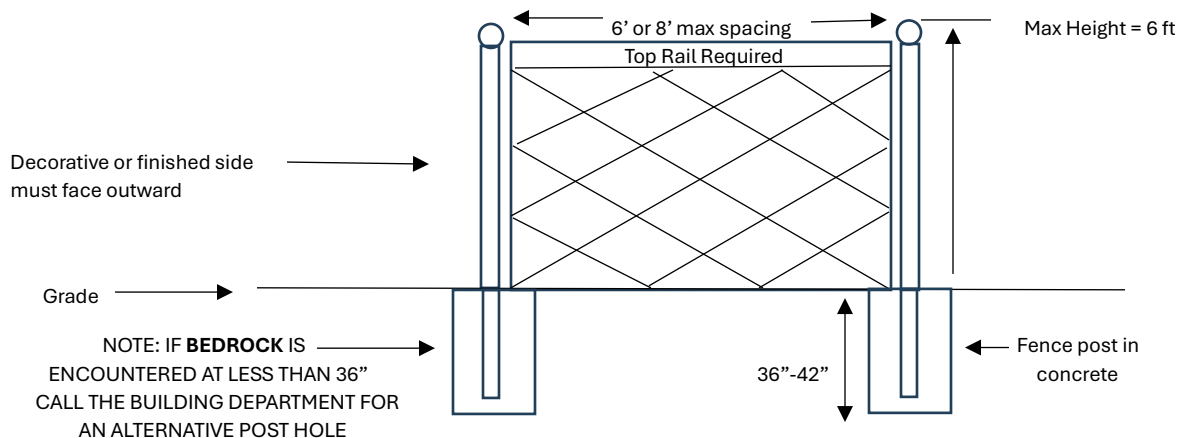
LOCATION

Fences are allowed on side and rear yards only.

Front yard fences are not allowed. The front fence may not extend past the front of the house.



CONSTRUCTION STANDARDS



OTHER STANDARDS

1. There may be no more than one perimeter fence per property line.
2. Fences must be architecturally compatible with the neighborhood and all fence panels must be uniform.
3. Fences may not be constructed to create a traffic or pedestrian hazard.
4. Fences may not be erected to encroach on another property.
A Plat of Survey is required to avoid encroachment.
5. Barbed or razor wire, etc., is not allowed in residential areas.
6. Dog runs are required to be a minimum of 8 feet from side and rear property lines and twenty-five (25) feet from neighboring houses.

PERMITS

A permit **must** be obtained prior to beginning fence construction. A permit application must be completed and submitted to the Building Department, along with a copy of a **PLAT OF SURVEY** for the property. Please draw all existing and proposed fence locations and dimensions in the copy of the Survey.

INSPECTIONS

- o **POST HOLE INSPECTION** – Postholes must be inspected prior to installing posts. This is to determine proper depth and placement.
- o **FINAL INSPECTION** – After entire fence project is completed.
